This preliminary application is to be sent to the Arizona Membership Chairman with a non-refundable **\$5** check payable to the "Arizona Mayflower Society". The \$5 check covers postage and application materials. You will be then be sent an application kit. When your final application with documentation is ready you will send it to the Arizona Society Historian for approval. This must be completed within two years. At that time a check for **\$108** is required to cover the initiation fee and 1st year dues of \$28. The dues apply to the calendar year in which the applicant's membership is finally approved at the General Society, except that if such date falls after Oct. 1, then the dues will be credited to the following calendar year. If the application, with a complete lineage worksheet and documentation is rejected for insufficiency of proof, then that portion of the \$108 initiation fee representing the 1st year's dues or \$28 will be refunded on request.
